In compliance with the April 15, 2021 County of Los Angeles Public Health Order, the Council Chamber will be open for public comment, including public seating available at limited capacity. Citizens are required to wear masks, provide proof of vaccination or negative COVID-19 test within 72 hours of the meeting and practice social distancing. If one of these criteria is not met or the person cannot show such documentation, the person will not be allowed to enter the Council Chamber to participate in the meeting. Councilmembers may choose to participate via conference call.
